Short title and commencement

Amendment of rule 6

In the principal Rules, in rule 6, in the proviso (b), the punctuation mark "." appearing at the end shall be deleted and after the words "two or more Secretaries", the words and punctuation mark "and the senior most Secretary of the Department as defined under clause (i) of rule 2 of these rules shall be the official head of that Department." shall be inserted.
