ORDERS BY THE GOVERNOR NOTIFICATION

No AR.122/2018/27: In pursuance of the decision taken in the State Cabinet meeting held on 01-06-2018, the Governor of Assam is pleased to order the transfer of Administrative control of Revenue fisheries from Revenue & Disaster Management Department to Fishery Department, Government of Assam with immediate effect, subject to the following terms and conditions:

- The administrative control of revenue fisheries is transferred from Revenue & Disaster Management Department to Fishery Department to enable the Fishery Department to exercise the powers conferred by the Section 16 Read with Section 155 &156 of the Assam Land and Revenue Regulation (ALRR), 1886 for sustainable development and management of such fisheries.
- 2. The settlement of transferred fisheries shall be governed by the Assam Fishery Rules, 1953 and shall be made by the Government in Fishery Department henceforth.
- The settlement of revenue fisheries at the field level, shall however will continue to be made by DCs/SDOs as is being done now under Assam Fishery Rules, 1953.

This Notification will come into force with immediate effect.
