 Any eligible citizen applying for Senior Citizen Certificate will submit application, in duplicate, in prescribed form, finalized by the concerned Deputy Commissioner along with 2(two) copies of stamp-sized photographs to the notified Designated Public Servant of the respective District with anyone of the self-attested / authenticated photocopies of the following documents:-

For Proof of Age :-

- Valid Passport.
- 2. PAN Card.
- Pension Payment Order from the competent authority.
- Marriage Certificate in case of change of name of women.
- In absence of above documents, the applicant will submit a certificate to be issued by Gaon Burha or Local Mauzadar.
- 6. School Certificate.
- Bank Pass Book with photograph.

For Proof of Name :-

- Valid Passport.
- 2. PAN Card.
- School Certificate.
- Identity Card issued by Competent Authority.
- Bank Pass Book with photograph.
- 6. Marriage Certificate in case of change of name of women.

For Proof of Residence :-

- Ration Card.
- Valid Passport.
- Voter ID Card.
- Electricity Bill / Telephone Bill.

- Any eligible citizen of the state of Assam who has completed 60 (sixty) years of age will submit application for issue of Senior Citizen Certificate before the Designated Public Servant of the respective Districts with the documents stated at page-1 and above.
- After receiving the application for issue of Senior Citizen Certificate, the
 Designated Public Servant will immediately verify the document and
 deliver the service to the applicant in the light of the Section-6 and
 Section-7 of the ARTPS Act, 2012, within 20(twenty) days from the date
 of submission of the application.
- In the case of rejection of the application, the Designated Public Servant shall record the reasons of rejection in writing and communicate to the person making the application with strict aherence to the Section-7(2) of the ARTPS Act. 2012.

This will come into force with immediate effect.
